

Creazzia Privacy Policy

Creazzia, located in Tilburg Netherlands, respects your privacy. We declare that we treat your personal data with care and confidentiality, in accordance with the applicable privacy legislation. The following describes how Creazzia collects, processes and uses data.

1. Personal data

Creazzia collects and processes your personal data because you use our services and / or because you provide these to us yourself, for example by completing and sending a form or sending an e-mail.

The most common data that Creazzia collects is contact details such as first and last name, and email. We will contact you through this data to provide requested information and services, to provide relevant information (such as adaptation of this privacy policy) and to use it for statistical purposes.

2. Automatically collected non-personal usage information

In order to continue to improve Creazzia website and to adjust it to visitor preferences, we will sometimes collect non-personal data, such as browser version or computer operating system a visitor uses, IP addresses assigned by providers, number of visits to Creazzia website.

3. Children's privacy

Our website and / or service does not intend to collect data about website visitors who are younger than 18 years of age, unless they have permission from parents or guardian. However, we cannot check whether a visitor is older than 18 years. We therefore advise parents to be involved in the online activities of their children, to prevent data about children being collected without parental consent. If you detect or are convinced that we have collected personal information about a minor without that permission, please contact us at info@creazzia.com and we will remove this information.

4. Sharing data to third parties

Your data will never be provided to third parties unless you have given your explicit permission.

5. Safety

We have implemented measures to protect your personal data against loss, misuse and unauthorized access or disclosure, for example by offering a secure connection on Creazzia website / email. However, no security system can offer guarantees against unauthorized access and therefore we

cannot completely eliminate security risks related to your personal information. You must take these security restrictions into account when you provide us with personal information.

6. View, modify or delete data

You have the right to view, correct or delete your personal data. In addition, you have the right to withdraw your consent for data processing or to object to the processing of your personal data by Creazzia and you have the right to data transferability. This means that you can submit a request to us to send the personal data that we hold about you in a computer file to you or another organization mentioned by you. You can send a request for access, correction, deletion, data transfer of your personal data or request for withdrawal of your consent or objection to the processing of your personal data to info@creazzia.com. To ensure that the request for inspection has been made by you, we request that you send a copy of your proof of identity with the request. Make in this copy your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Citizen service number (BSN) black. This is to protect your privacy. We will respond to your request as quickly as possible, but within four weeks. Creazzia would also like to point out that you have the possibility to file a complaint with the national data protection authority, the Dutch Data Protection Authority. 8. Updates to Creazzia privacy policy

We reserve the right to change, modify, add or remove parts of this privacy policy at our own discretion. We will post a notice of such changes on the Creazzia website or notify you by e-mail of such changes to the e-mail address we have registered for you. If you continue to use our websites after a change has been made, your use indicates that you agree that you have read, understood and accepted the changed privacy policy. If you do not agree to any changes to this privacy policy, you must stop using our websites, email and services, and request removal of your information from our databases.
